ANNOTATSIYA

Mazkur maqola O‘zbekistonda buxgalteriya hisobiniyuritshni takomillashtirishni avtomatlashtirishga haqida ma’lumotlar tahlil qilinadi. Xususan buxgalteriya hisobini bugunda turli dasturlar yordamida amalaga oshirilmoqda. Bularga quyidagi dasturlarni kiritish mumkin: 1S, 1UZ, BEM, UzASBO, ERP (Enterprise resource planning system) va boshqa dasturlar yordamida amalga oshirilmoqda. Bugun men sizlarga buxgalteriya hisobini yuritishda eng ko‘p qollanilayotgan 1S va UzASBO dasturlarining qay tartibda ishlashi va ularning byudjet tashkilotlarida qanday maqsadlarda foydalanilish haqida ma’lumot beriladi.

KIRISH.

1S kompaniyasining 1991 yilda, ya'ni bozor iqtisodiyotining birinchi belgilari paydo bo'lgandan so'ng tug'ilgan. Uning asoschisi uning doimiy rahbari Boris Georgievich Nuralievdir.

1992 yilga kelib, o'z mahsuloti 1s buxgalteriya prototipi tayyorlandi. Uning e'loni 1992 yilda Comtek ko'rgazmasida e'lon qilingan, u erda Lotus 1-2-3 "stollari" va o'zining 1S mahsuloti namoyish etilgan. 1S buxgalteriya hisobining yaratilish tarixi kompaniyaning o'zi yaratilishidan ko'ra sirliroqdir. Dastlabki kodning rasmiy ishlab chiqaruvchisi 1S kompaniyasi rahbarining ukasi - Sergey Nuraliev bo'lib, u akasi bilan buxgalteriya hisobida yarim kunlik ishlagan va o'z ehtiyojlari uchun dasturni ishlab chiqdi - bugungi 1S buxgalteriya hisobining prototipi. Dasturiy ta'minot mahsuloti, hatto asl nashrida ham, juda muvaffaqiyatli bo'ldi - uch yuzdan ortiq nusxalar birinchi nashrlarning floppi disklarida sotilgan.

Dasturdan foydalanish bepul bo'lib, hozirda undan 26000dan ortiq tashkilotlar foydalanib kelmoqda.

MUHOKAMA VA NATIJALAR.

1S: Buxgalteriya 8,0 amaliy dastur paketi imkoniyatlari.

1S: Buxgalteriya 8,0 da barcha ma’lumotlar, bank hisoblari, ruyxat kodlari va korxonalar ishchilarining (pasport ma’lumotlari, kodlari, mansablari, maoshlari) saklanadi; 1S: Buxgalteriya 8.0 da barcha buxgalteriya, soliq hisobotlari avtomatik tarzda tashkil topadi

va ulami IFNSga chop etish yoki faylda saqlash mumkin. Hisobot tuzishni boshlash IS:Buxgalteriya 8.0 da ishni boshlash uchun korxonaga haqidagi ma'lumot va korxonaning siyosiy taraflarini bilishning o'zi kifoya. Bunda dastur barcha dalillar orqali ish boshlashga moslashadi. Oddiy hujjat to'ldirish IS:Buxgalteriya 8.0da hujjatlarni todirishda ko'pgina ma'lumotlar avtomatik tarzda bariladi. Hisobotni yozish uchun ma'lumotni keltirish va tovar yoki xizmat turlarini ko'rsatish kifoya. Keltirilgan ma'lumotni bir hujjatdan ikkinchi hujjatga ko'chirib o'tkazish. Masalan: hisobot asosida yuk-xati yozish mumkin. Hisobotning oddiy tahlili IS:Buxgalteriya 8,0 ning tezkor tahlilini bilish uchun quyidagi hisobotlarni ko'rib chiqiladi: aylanma qoldiq hujjatlari, hisob-kitob tahlili, hisob-kitob varag'i va boshqalar. Har qanday hisobot kerakli ma'lumotni olish uchun tuziladi. Masalan: omborga keltirilgan turli markadagi ventilyatorlarni hisobini olish uchun «Aylanma qoldiq vedomost orqali 4/,01, hisobotga yoziladi. «Ombordagi tovar» hisob varaqasi orqali ventilyatoming qanchaligini bilish mumkin. Buxgalteriya va soliq hisobotlarini tuzish 1S Buxgalteriya 8.0 soliq va buxgalteriya hisobotlarini tuzishni yengillashtiradi. Masalan: buxgalteriya balansini tuzish uchun uning hisobot davridagi ahvolini ko'rsatish kifoya. Hamma ko'rsatgichlarni dastur o'zi to'ldiradi. Barcha hisobotlar dasturda saqlanadi. Hisobot ko'rsatkichlarini esa qo'l orqali kiritish mumkin va ushbu o'zgarishlarni dastur o'zi yodda saqlab qoladi. Ko'rsatkichlarni yuborib bank to'lovnomasini olish mumkin. 1S:Buxgalteriya 8.0 da aks etgan barcha to'lov hujjatlari osongina «Bank-mijoz» dasturi hisobiga kelib tushadi. Bankdan olingan ma'lumotlar ham osongina kirim to'lovnomalarida aks ettiriladi. 1S Buxgalteriya 8,0 orqali ma'lumotlarni almashishni 700dan ziyod kredit tashkilotlari qo'llab-quvvatlaydi. 1S:Buxgalteriya 8.0 asosiy afzalliklari: Soliq va buxgalteriya hisobini nazarda tutmagan holda ma'lumotlarni IS:Buxgalteri 8.0ga qisman kiritish orqali Tovar-moddiy zaxiralarini o'rtacha tannarxni qo'llab FIFO va LIFO usullarida hisoblashdir. Chakana savdodagi mahsulotlarni sotuv narxida hisob-kitob qilish imkoniyati yaratilgan (42 schyotni qo'llagan xolda «Savdoni baxolash») 40 schyotni qo'llagan va qo'llanilmagan holatda tayyor mahsulot ishlab-chiqarish jarayonini aks ettirish imkoniyati ko'zda tutilgan «Mahsulot ishlab-chiqarish (ish, xizmat)» Soliq va buxgalteriya hisobotida xo'jalik operatsiyalarini aniq holda hujjatlarda aks ettirish imkoni mavjud. Tovarlar va materiallar hisob schyotini nomenklatura va saklash joyi uchun berish mumkin. Shartnoma va hisob turlari xar bir kontragent uchun alohida hisob schyoti beriladi. Berilgan hisob schyotlar hujjatlarga avtomatik tarzda kiritiladi.

Hozirda byudjet tashkilotlari tomonidan ish haqi va unga tenglashtirilgan to'lovlar bo'yicha xarajatlarga naqd pul olishga so'rovnomalar - g'aznachilik organlariga, jamg'arib boriladigan pensiya badallari bo'yicha xodimlar restri - Xalq banki filiallariga, plastik vedomostlar ro'yxati esa Ipoteka bank, Agrobank, Mikrokreditbank, Qishloqqurilishbank, O'z sanoatqurilishbank, Asaka bank, Turonbank, Xalq banki va Ipak yo'li banklariga elektron ko'rinishda yuborilmoqda.
